This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purpose for which this corporation is organized is to raise funds to support lung cancer patients and their families in memory of Linda Skeeles who died of lung cancer in 2005. To further provide funds for lung cancer research and new diagnosis initiatives.
