**ARTICLES OF INCORPORATION  
OF  
YACHT CLUB OF GULF HARBOUR, INC.**

The undersigned, desiring to form a corporation not-for-profit under Chapter 617, Florida Statutes as amended, hereby executes and adopts the following Articles of Incorporation ("Articles"):

**ARTICLE 1 - NAME AND ADDRESS**

The name of the corporation shall be YACHT CLUB OF GULF HARBOUR, INC. (hereinafter referred to as the "Corporation"). Its principal office and mailing address shall be at 14490 Vista River Drive, Fort Myers, Florida 33908, or at such other places as may be designated, from time to time, by the Board of Directors.

**ARTICLE 2 - PURPOSE**

The general nature of the objects and purposes of this corporation shall be:

1. To promote boating education, cruising and social activities, fostering fellowship among members with shared goals and interests through participation in shared activities.
2. To do any and all things necessary and appropriate in connection with the foregoing purpose and incidental thereto.
3. The corporation's purposes are hereby limited in such a manner as will qualify it as an exempt organization under Section 501(c)(7) of the Internal Revenue Code of 1986, as amended ("Code"), or under any corresponding provision of any subsequent federal tax laws.

**ARTICLE 3 - MEMBERSHIP**

The membership of this corporation shall consist of all persons hereinafter named as Directors and such other persons as, from time to time hereafter, may become members in the manner provided in the Bylaws.

**ARTICLE 4 - TERM OF EXISTENCE**

This corporation shall commence upon the filing of these Articles and shall exist perpetually thereafter.
