ARTICLES of INCORPORATION

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation Law of the State of Florida, do hereby certify:
Article I: The name of the Corporation shall be The Ministries of Sharon's Rose, Incorporated.

Article II: The place in the state where the principal office/of the Corporation is to be located in the unincorporation area of Saint Lucie County on Hutchison Island, address 112 South Las Olas Drive, Jensen Beach, Fl. 34957, United States.

Article III: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article IV: The manner in which the directors are elected or appointed are as follows: The initial appointment of officers shall be made by the Founder and Chairperson Sharon Thompson, subsequent appointments shall be through an election for Officers and General Board by the Ministries' members with the approval of the Chairperson. Each elected official shall hold the Board position for a period of two (2) years, with the exception of Chairperson, which will be a life-time position and with all executive powers related to the position of Chairperson which will include, but not limited to: Veto power, Final decision making in tie situations, and all financial control. Any Board member may re-elected if voted into the position by Fifty-one percent (51 %) of the general membership, and Chairperson approval.

Article V: Initial Directors and/or Officers shall be: Sharon Thompson, Chairperson

Article VI: No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political

campaign on behalf or in opposition to any candidate for public office. Notwithstanding the provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future tax code. Notwithstanding any other provisions of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercises any powers that are not in furtherance of this purposes of this corporation. In reference to federal law stated this statement has been added if limitations imposed by said federal law are invalid in the state of Florida.

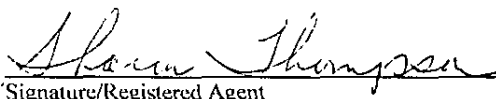
Article VII: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code, or the corresponding section of any further federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the country in which the principal office/church of the corporation is then located, exclusively for such purposes or to such operated exclusively for such purposes.
