ARTICLES OF INCORPORATION

OF

LEININGER FAMILY FOUNDATION, INC.

The undersigned, for the purpose of forming a corporation not-for-profit under the laws of the State of Florida, Chapter 617, the Florida Not-For-Profit Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I Name

Section 1.1 - Name. The name of this corporation shall be LEININGER FAMILY FOUNDATION, INC.

ARTICLE II Principal Office and Mailing Address

Section 2.1 - Principal Office and Mailing Address. The principal place of business of this corporation shall be 1031 1st STREET SOUTH, UNIT 1107, JACKSONVILLE BEACH, FLORIDA 32250; and the mailing address of this corporation shall be 1031 1st STREET SOUTH, UNIT 1107, JACKSONVILLE BEACH, FLORIDA 32250.

ARTICLE III Purposes

Section 3.1 - Purposes. This corporation is organized exclusively for charitable, educational, religious and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or corresponding section of any future federal tax code. Section 3.2 - Limitations on Actions. All of the assets and earnings shall be used exclusively for the purposes set forth herein, and no part of the net earnings of the corporation shall enure to the benefit of, or be distributable to, its directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered. No substantial part of the activities of the corporation shall be the carrying-on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office.

ARTICLE XI Amendment

<u>Section 11.1 - Amendment.</u> This corporation reserves the right to amend or repeal any provision contained in these Articles of Incorporation.
