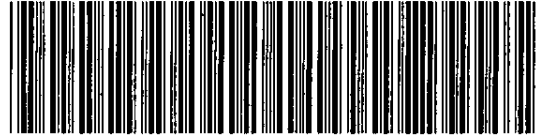

**ARTICLES OF INCORPORATION
OF
GLOBAL CHURCH OF GOD BY FAITH, INC.**

I, the undersigned natural person of the age of eighteen (18) years or over, resident of the State of Florida as an incorporator under the Florida Non- Profit Corporation Act (in compliance with Chapter 617, F.S., (Not for Profit), do hereby adopt the following articles of corporation for such corporation:

ARTICLE I: NAME,

The name of the corporation shall be known as:
GLOBAL CHURCH OF GOD BY FAITH, INC.

ARTICLE II: NON-PROFIT CORPORARION

This corporation shall be a religious non- Profit Corporation.

ARTICLE III: DURATION

This period of its duration is perpetual corporation.

ARTICLE IV: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 1908 Silver Star Road, Orlando, FL. 32804 and P.O. Box 555748, Orlando, FL. 32855

ARTICLE V: PURPOSE

The primary purpose for which this corporation is organized is: To obey and to carry out the Great Commission of Jesus Christ according to Matthew 28:18-20 and Mark 16-16-20.

- This corporation will establish congregations to teach, equip, disciple, and establish believers in the faith with the Word of God.

- It will train, license, ordain, commission, and sponsor missionaries and ministers of the Gospel in the five- fold Ministries of Apostles, Prophets, Evangelist, Pastors, Teachers, and Missionaries (Ephesians. 4: 11-130 and church workers- Elders Deacons Deaconesses etc.)

It will carry out humanitarian endeavors and projects- feeding, housing, and clothing the homeless, orphans, needy, and destitute in the society.

It will print and publish books, magazines, journals, and news letters

It will own, manage and operate Christian schools and educational institutions, TV, radio, bookstores, Life and Youth Centers, clinic, hospitals, and senior citizen homes and centers.

It will have the right to own, hold, use, sell, convey, and borrow money, mortgage or otherwise deal in real or personal property.

It will be involved in other projects, programs, and endeavors in line with its primary purpose and in compliance with the laws of the land.

ARTICLE VI: MANNER OF ELECTION

The directors are elected by the members of the board of directors in accordance with the constitution of the corporation.

ARTICLE IX: DISSOLUTION

Upon the dissolution of this corporation, or in the event that it ceases to carry out the objectives and purposes herein set forth, the Board of Directors are to comply with the regulations under the Internal Revenue Code 501 (C) (3) of 1986. All the business properties and assets of the corporation shall go to and be distributed to any other non-profit charitable corporation qualifying as an organization exempt under the provisions of section 501 (c) (3) of the IRS as the Board of Directors may select and designate. In no event shall any of the paid assets or properties in the event of dissolution thereof, go or be distributed to any individual. It is the intent that the dissolution be through the proper judicial jurisdiction: The district court of the county which

the principal office of the corporation is located, exclusively for such purposes or the organization as said court should determine which is organized and operated exclusively for such purposes. All liabilities and obligations of the corporation shall be paid, satisfied, or discharged.

Assets held by the corporation upon dissolution requiring return, transfer or conveyance which conditions occur by reasons of dissolution must be returned or conveyed in accordance with such requirements.
