Certificate of Non-Profit Incorporation Of

Daytona Beach Reserve Police Officers Association, Inc.

Article 1: The name of this corporation shall be:

Daytona Beach Reserve Police Officers Association, Inc.

Article 2: The duration of existence of the corporation shall be in perpetuity.

Article 3: The specific and primary purpose for which this corporation is formed is to Promote and protect the welfare and just treatment of the members of the Daytona Beach Reserve Police Officers Association, Inc. (DBRPOA). The DBRPOA shall also engage in related activities of goodwill, charity, and activism as a force for positive change within the Daytona Beach Police Department, the City of Daytona Beach, and the County of Volusia.

Article 4: Nominations and Elections- During the November DBRPOA meetings of every odd year, nominations will be accepted for the positions of President, Vice-President, Secretary, Treasurer, and one of the Trustee positions. The second Trustee shall be appointed after the elections by majority vote of the five newly elected members of the board. The newly elected President shall appoint the third trustee after the elections. There shall be multiple meetings during the month of November to allow all shifts to attend (A minimum of two meetings is suggested.) The Elections Committee shall be formed to assist with the process of the elections at this time. Nominations will only be accepted from DBRPOA members actually in attendance at one of the several November meetings. The nominees themselves need not be present, but they must have given notice that they will accept nominations. The Elections Committee shall be responsible to verify the eligibility of candidates and the acceptance of nominations.

The Elections shall occur after January 1st of the following year and shall be completed by January 20th. The Elections Committee shall prepare a locking ballot box and staff such ballot box at a location within the City of Daytona Beach that is easily accessible by all members of the DBRPOA. The polls may be opened and closed as necessary to allow all members of the DBRPOA a reasonable time to cast their vote. The vote shall be cast by slated ballots. Votes can only be cast for nominated candidates. If only on candidate is nominated for an office, that candidate shall be elected by default and no election shall be necessary for that position. Upon closing of the polls, the Elections Committee shall count the ballots. The candidate with the highest number of votes shall be elected. In the case of a tie there shall be a runoff between the two top candidates. If the runoff concludes in a tie, a coin toss shall decide the election.

The elected candidates shall assume their duties immediately. The five newly elected board members, President, Vice-President, Treasurer, Secretary and Fist Trustee, shall by majority vote chose the second trustee. The board may chose any person willing to accept the position from the membership of the DBRPOA, including but not limited to unelected candidates. The newly elected President shall then appoint the third Trustee

from amongst the membership of the DBRPOA. Once appoint or elected, trustees can only be removed from office by the means detailed in these articles. The trustees cannot be un-appointed by the President or un-elected by the board. Regardless of appointment of election method, all trustees have the same duties, responsibilities, and powers.

- Article 5: Membership in the DBRPOA shall be restricted to current dues paying members of the DBRPOA of the rank of Sergeant and below that are fully certified reserve police officers of the City of Daytona Beach Police Department. Only current members can vote during a membership meeting. Only current members can hold positions within the DBRPOA. A member may bring one guest to meetings of the DBROA with prior approval of the executive board to attend or remain. Guests may only speak upon the recognition of the President or the presiding officer.
- Article 6: In addition thereto, the corporation shall have the further general purposes and powers as follows but not limited thereto, as well as all such powers to engage in any lawful act or activity for which not-for-profit corporations may be organized under the laws of this state, viz.:
 - a) To sue and be sued;
 - b) To publicize, publish, promote, teach, inform, research, and explore all the matters of the world as its directors may be moved to do, and to exercise any, all, and every power to which an establishment of law enforcement officers are entitled.
 - c) To create, modify, or dissolve educational, informational and instructional bodies, schools or public safety organizations, societies or fraternities and sororities, and other subsidiary organizations as the Board of Directors may from time to time direct.
 - d) To authorize, bestow, convey, grant or issue certificates, charters, degrees, credentials, diplomas, franchises, licenses, memberships, or to do otherwise as the Board of Directors may from time to time direct.
 - e) To establish various and diverse classes of memberships as the Board of Directors may from time to time direct.
 - f) In furtherance of its mission, it shall, as the Board of Directors may from time to time direct, borrow moneys, contract debts, receive property by devise, bequest or trust, to issue bonds, notes and debentures as allowed by law, and to secure, pay interest on and redeem same; to securities of other corporations; to act as the trustee
 - g) under any trust incidental to the principal objects of the corporation, and receive, hold, administer and expend any funds and property subject to such trust.
- Article 7: The corporation shall not have any capital stock and the conditions, classes and powers of membership shall be as stated in the bylaws.
- Article 8: The activities and affairs of the corporation shall be managed by the Board of Directors. The number of Directors which shall constitute the whole board shall be as from time to time fixed by, or in the manner provided in the bylaws, but at not time shall it be less than four nor exceed seven.

- Article 9: The Board shall adopt and from time to time as it deems necessary, amend the bylaws or Articles of the corporation by a majority vote of the Directors in attendance at a meeting called for the purpose after proper notice.
- Article 10: The meetings of the Board of Directors may be held in any location whatsoever, within or without this State, subject to the provisions of the bylaws. The books of the corporation may be kept at any location allowed by law not inconsistent with the bylaws of the corporation.
- Article 12: The corporation reserves the right to amend, alter, change or repeal any provision contained in this Certificate of Incorporation in the manner now or hereafter prescribed by the laws of this state, to be effective upon completion of a majority vote and the subsequent filing with the proper authorities of this state, and all rights conferred upon any members herein are granted subject to this reservation.
- Article, 13: No substantial part of the activities of this corporation or any subordinate organization shall consist of carrying on propaganda, or otherwise attempting to influence legislation beyond that specifically permitted by law and the Internal Revenue Code of the Treasury Department of the United States of America.
- Article 14: The property of this corporation is irrevocably dedicated to improvement of social and public purposes. Upon liquidation, dissolution, or abandonment by this corporation, after providing for the debts and obligations of this corporation, all remaining assets will not inure to the benefit of any private person, but will be distributed to another 501(c) (3) or 170 © (2) qualified, non-profit foundation or corporation which is organized exclusively for law enforcement personnel/or charitable purposes and which is entitled to or already has established tax-exempt status under the previously mentioned sections of the Internal Revenue code, or the corresponding sections of any future applicable tax code.
- Article 15: The principal office and registered office of the Corporation in this State shall be 2256 Coconut Blvd., Bunnell, FL 32110 and the Registered Agent in charge thereof shall be Robert Engborg, located at that same address.
- Article 16: The effective date of incorporation of the Daytona Beach Reserve Police Officers Association, Inc. shall be January 1, 2008.
