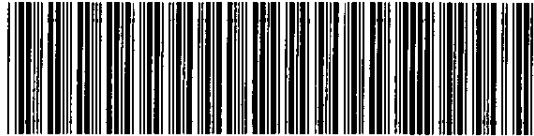

BY THESE ARTICLES OF INCORPORATION the incorporator forms a not for profit corporation under Florida law.

1. NAME. The name of the corporation is KIWANIS CLUB of CAPE CANAVERAL-PORT CANAVERAL, INC.

2. ADDRESS. The mailing and street address of the principal office of the corporation is 200 International Drive #510, Cape Canaveral, Florida 32920.

3. TERM. This corporation shall exist perpetually.

4. PURPOSES. The purposes for which this corporation is organized shall be:

(a) To give primacy to the human and spiritual rather than to the material values of life.

(b) To encourage the daily living of the Golden Rule in all human relationships.

(c) To promote the adoption and application of higher social, business and professional standards.

(d) To develop, by precept and example, a more intelligent, aggressive and serviceable citizenship.

(e) To provide through this club a practical means to form enduring friendships; to render altruistic service; and to build better communities.

(f) To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice and patriotism and good will.

(g) For the purposes aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of Cape Canaveral-Port Canaveral, Florida, and its members.

(h) To do all things incidental or conducive to the attainment of the above objects.

5. STOCK. This corporation shall issue no stock.

6. MEMBERS. The qualifications for and manner of admission of members shall be regulated by the bylaws.

6. CHANGE IN CORPORATE STRUCTURE. Whenever requested by the Board of Trustees of Kiwanis International the corporation will dissolve or change its form of organization, and no change in the corporate structure or in the purposes and powers of the proposed corporation should be made without the consent of Kiwanis International.

7. DISSOLUTION. Upon the dissolution of the corporation, the governing board shall, after paying or making provision for the payment of all of the liabilities of the corporation dispose of all of the assets of the corporation exclusively for the purposes of the corporation, in such manner to such organization or organizations organized or operated exclusively for charitable, educational, religious or scientific purposes, as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1954 (or corresponding provision of any future United States Internal Revenue law), as the governing board shall determine. Any of such assets

not so disposed of shall be disposed of by the District Court in the county in which the principal office of the corporation is located, exclusively for such purposes.

8. REGISTERED OFFICE. The initial registered office of the corporation is 200 International Drive, Apt. 510 Cape Canaveral, Florida 32920 and its initial registered agent is Eileen Kandret.

9. DIRECTORS. The corporation shall have a have a Board of Directors consisting of five officers, President, President Elect, Immediate Past President, Treasurer, and Secretary and five elected directors. The name and address of each person who is to serve as initial directors is:

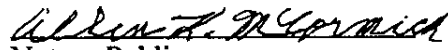

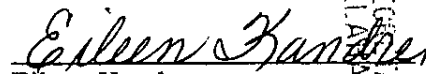
