**Articles of Incorporation**

Effective Date *Jan. 01, 2008*

The undersigned incorporator (s), for the purpose of forming a non-profit corporation under the Florida Business Corporation Act, hereby adopt (s) the following Articles of Incorporation.

**ARTICLE ONE**

The name of the corporation shall be:

Wild at Heart Adventure Ministries, Inc.

The corporation shall commence on January 1, 2008.

**ARTICLE TWO**

The place in this state where the principal office of the corporation is to be located is in the city of Delray Beach, Palm Beach County.

The principal place of business physical address shall be:

**ARTICLE THREE**

This corporation is organized exclusively for the charitable, religious, educational, and scientific purposes, including, but not limited to, the making of distribution to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. In addition, this corporation is organized to explore God's magnificent creation through sailing, hiking, camping, canoeing, kayaking, fishing, and snorkeling. It will teach some survival skills, give sailing and canoeing instruction, and any and all allowable activities of a non-profit 501 (c) (3) organization.

#### ARTICLE FOUR

The manner of election of the Board of Directors shall be by a majority vote or as stated in the By-Laws.

#### ARTICLE FIVE

This corporation certifies that no part of the net earnings shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in article three hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

## ARTICLE SIX

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue code, or the corresponding section of any future federal tax code, or shall be distributed to the Federal Government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine which are organized and operated exclusively for such purposes.
