**ARTICLES OF INCORPORATION
OF
Church of Salvation Inc.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I NAME

The name of the corporation shall be: Church of Salvation Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:
405 Springview Drive, Sanford, Florida 32773

ARTICLE III PURPOSES

The specific purpose for which the corporation is organized is: The Corporation's business purpose is to establish itself within the community as a church with a sole purpose and mission to help transform, rebuild and restore lives within our community by carrying out the commission of our Lord and Savior Jesus Christ. We will feed the hungry, find shelter for the homeless, help the poor and less fortunate, visit the sick and help those that are getting out of prison make the difficult transition from incarceration back into society. Most importantly we will serve as a meeting place and a refuge where the community will be able to assemble and congregate to hear the preachings and teachings of the Gospel of Jesus Christ while saving lives and winning souls.

This corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
