## ARTICLES OF AMENDMENT ARTICLES OF INCORPORATION FOR BAND OF PIRATES AND GUARD BOOSTER CLUP INC. DOCUMENT NUMBER NO7000011747

### **ARTICLE III PURPOSE**

This Corporation is a Not For Profit Corporation. The purposes for which this Corporation is organized are:

- a. Exclusively for charitable and educational purposes, including, for such purposes the making of distributions to organizations that qualify as exempt organizations within the meaning of Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The charitable and educational purposes are as follows: The advancement of education and musical development of High School students, by supporting them while they compete in National and International musical competitions. This will enhance their musicianship through discipline and scholarships.
- b. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

#### ARTICLE IV DISSOLUTION

Upon the dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which is organized and operated exclusively for charitable, educational, religious, and scientific purposes and which has established its tax exempt status under Section 501 (c) (3) of the Internal Revenue Code.
