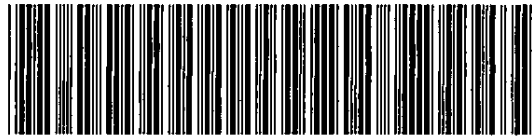

The undersigned, acting as the incorporator of a not-for-profit organization under the Florida Not for Profit Corporation Act, as set forth in Chapter 617 of the Florida Statutes, as amended, adopt the following Articles of Incorporation for such corporation:

### **ARTICLE I: NAME**

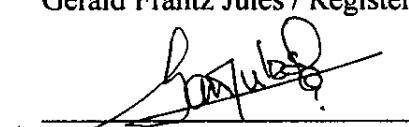

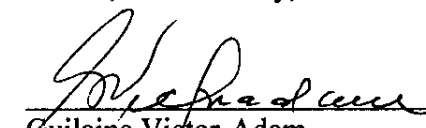
