ARTICLE OF INCORPORATION OF THE ALLOCATIONS INC.

The undersigned, as incorporators, all of whom are the citizens of the United States of America, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Laws of the State of Florida, adopt the following Articles of Incorporation, and do hereby certify:

ARTICLE I

ARTICLE III

6.1 The Corporation shall be a Non-Profit Corporation. This Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

6.3 The Corporation is formed to meet the substantial requirements in the community and promote the advantage (power) of an education. Promote and educate towards unified family structure, to educate honestly about African American history, and to champion a campaign that promotes prominent African American icons.

6.4 The Corporation reserves its right to exercise the powers provided for Non-Profit organizations in Prison Ministry, including ex-offender programs, parole and probation associations, Anti-crime. drug, sexual deviancy, and promiscuity. Faith based Christian principles and any subsequent amendments thereto, including any and all things whether therein mentioned or not necessary or incidental to the carrying out of the purposes set forth herein. Such powers shall be construed liberally, and shall not be construed as a limitation of the Corporation's ability, it being intended that the Corporation shall have all the rights, powers, and privileges that any Non-Profit organization would have.

ARTICLE IV

The place in this state where the principle office of the Corporation is to be located is the City of Jacksonville, County of Duval, and the State of Florida. All of the appointed Directors are appointed based on their qualifications, experience, and ability to ensure that the Corporation is able to meet the substantial needs of the community and people in which the Corporation intends to serve.
