The undersigned, acting as incorporators of a corporation not for profit, pursuant to Chapter 617, Florida Statutes, adopt the following articles of incorporation for such corporation:

ARTICLE I:

NAME

The name of the corporation shall be: Iglesia Cristiana Emanuel, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 3239 John Young Parkway, Kissimmee, FL 34746.

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is:

- 1. To establish and maintain a local congregation of the Iglesia Cristiana Emanuel, Inc.;
- 2. To spread the Gospel of Jesus Christ, promote holiness and worship of God among its members and attendants, and the practice of Christian virtues as admonished by the Holy Scriptures;
- 3. To employ and discharge ordained, licensed and commissioned ministers of the Gospel, and others, to conduct and carry on divine services at a place of worship, and elsewhere, and to collect and disburse any and all necessary funds for the maintenance of said corporation and ecclesiastical body being the local congregation known as Iglesia Cristiana Emanuel, Inc.;
- 4. To provide appropriate religious education and training for its member and those attending its church school and other educational meeting and classes;
