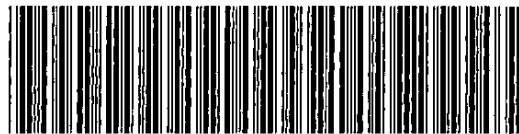

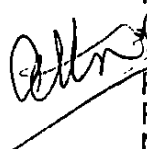

**ARTICLE I**  
**NAME/REGISTERED OFFICE**

The name of this corporation shall be ATIC & MG CENTER FOR EXCELLENCE, INC.

**ARTICLE II**  
**PRINCIPAL OFFICE**

**ARTICLE III**  
**PURPOSE**
