## ARTICLES OF INCORPORATION OF

CHRISTIAN CHURCH OF THE GALILEA INC.

WE, the undersigned, hereby associate ourselves for the purpose of becoming a not-for-profit Corporation under the laws of the State of Florida and are therefore bound by State Statutes regulating information, liability, rights, privileges and immunities of a not-for-profit Corporation.

#### ARTICLE I Name of Corporation

The name of this corporation is CHRISTIAN CHURCH OF THE GALILEA INC.

## ARTICLE II Purpose

The purpose of this corporation is to establish and maintain a regular church cooperating with the missionary program of the church, and to provide a place of public worship in the city of Lake Worth, Palm Beach County, Florida.

The church as a corporation may establish schools for religious teachings and may also have stations or other churches in other localities, counties or states.

In the pursuit of this goal, the Corporation can acquire, buy, hold, own, sell, exchange, convey, lease, or otherwise dispose of goods, chattels, effects and merchandise. It can also mortgage, lease, hypothecate, convey, exchange and dispose of lands ands chattels. It may enter any transactions deemed lawful authorized by the Board of Directors.

## ARTICLE III By-Laws

By-laws of the corporation are to be made, offered, and rescinded by a majority of the qualified members of the church, present and voting at a regular or special business meeting.

### ARTICLE III Corporate existence

This corporation shall exist for a perpetual period of time. It shall have offices throughout and outside the State of Florida.

### ARTICLE IV Principal Place of Business

The initial place of business is 1600L South Dixie Highway, Lake Worth, Florida 33460. The mailing address is as follows: 1600L South Dixie Highway Lake Worth, FL 33460

The Board of Directors may from time to time move the principal office to any other address in Florida and establish branch offices at any other place within or without the State of Florida.

#### ARTICLE V Dissolution

In the event of dissolution, the remaining or residual assets of CHRISTIAN CHURCH OF THE GALILEA shall be transferred to a not-for-profit organization qualified and in good standing under Section 501 (c) (3) of the internal revenue codes.

#### ARTICLE VI Prohibited Activities

Notwithstanding any other provisions of these articles, this corporation shall carry only activities permitted to be carried on by (a) a corporation exempt from Federal Tax under Section 501 (c) (3) of the internal revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law or (b) a corporation's contribution which are deductible under section 170 (c) (2) of the Internal revenue Code of 1954 or any other corresponding provisions of any future United States Internal Revenue law.

### ARTICLE VII Initial Board of Directors

Initially, this corporation shall have three directors. The number of directors may increase depending on business needs, but may never be less than one. The directors shall hold office for the first year of existence of the corporation and until their successors are elected or appointed according to the by-laws. Having been named as registered agent and to accept service of process for the above stated Corporation CHRISTIAN CHURCH OF THE GALILEA INC. at the place designated in this certificate, I hereby accept the appointment as registered agent and agree to act in this capacity. I further agree to comply with the provisions of all statutes relating to the proper and complete performance of my duties, and I am familiar with and accept the obligations of my position as registered agent as provided for in chapter 607, F.S.

These articles may be altered, amended or repealed and new articles may be adopted at any regular or special meetings of the Board of Directors and ratified by the majority of the shareholders.
