#### ARTICLES OF INCORPORATION

The undersigned subscriber, for the purposes of forming a corporation for not for profit under Chapter 617 of the laws of the State of Florida, hereby subscribes to,

#### ARTICLE I NAME AND ADDRESS

acknowledges and files the following Articles of Incorporation.

The name and address of the proposed corporation shall be Cristo Es Mi Roca, Inc. located at 4969 Gun Club Road in West Palm Beach, Florida 33415.

## DURATION

This corporation shall commence existence on the date of the execution and acknowledgment of these Articles if permitted by law; if not, then on the date of filing. This corporation shall exist perpetually thereafter, unless sooner dissolved according to law.

#### ARTICLE III **PURPOSE**

This corporation, Cristo Es Mi Roca, Inc., is formed for the following purpose:

- To disseminate the Gospel of Jesus Christ and the Word of God, to the end (1) that people may be evangelized and believers may be conformed to the image of Jesus Christ (Mark 16:15-16; Isaiah 6:8; Acts 13:47; II Corinthians 5:20); to regularly assemble for fellowship to worship God in Spirit and in truth (Hebrews 10:25) and to cooperate in the building up of the whole body of Christ (Ephesians 2:19-22).
- To provide basic New Testament discipleship to all who are approved for (2) this purpose by the Elders. (Acts 6:7, ll:26, 14:20-23)
- To establish and maintain a church and to provide a place of public (3) worship and prayer in accordance with the directions of the Holy Spirit (I Kings 8:12-21; Psalms 96:9, 122:1; I Corinthians 5:4); to spread the Gospel of the Lord Jesus Christ through the preaching and teaching of the Bible to bring the unsaved to Christ (Mark 6:15; Romans 1:15-16; I Thessalonians 5:9; II Thessalonians 2:13; II Timothy 3:15), and to build up the saved in Christian grace and living.

- (4) To promote fellowship, cooperation, protection, recognition and propagation of the Christian Gospel at home and abroad and for the support of public worship.
- (5) To receive and accept donations of real and personal property and to issue conditional certificates or otherwise on such forms as may appear best.
- (6) To act as beneficiary on all kinds of Insurance policies and Wills.
- (7) To receive and receipt for endowments of personal and real property and issue such certificates therefore as may appear proper.
- (8) To borrow money, give notes, issue debentures and to secure in such borrowing by pledge, mortgage or otherwise.
- (9) To establish churches, auxiliaries, clubs, schools, and societies of a religious nature.
- (10) To print, publish and distribute and sells books, magazines, tapes and other literature in any way connected with the purpose of this organization.
- (11) To do any and all things reasonably necessary to carry out the above and foregoing purposes.

# ARTICLE IV EXEMPT STATUS AND DISSSOLUTION

This corporation is organized and operated exclusively for religious purposes within the meaning of section 501(c)(3) of the Internal Revenue Code or the corresponding section of any future federal tax code.

- a. The property of this corporation is irrevocably dedicated to religious or charitable purposes, and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer, or member of the corporation, or to the benefit of any private person.
- b. Upon the winding up or dissolution of this corporation, after paying or adequately providing for the debts and liabilities of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation organized and operated exclusively for charitable or religious purposes and that has established its tax-exempt status under the Internal Revenue Code section 501(c)(3).
- c. No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, nor shall this corporation participate in, or intervene in (including the publishing or distributing of statements), any political campaign on behalf of any candidate for public office.

## ARTICLE V INITIAL BOARD OF DIRECTORS
