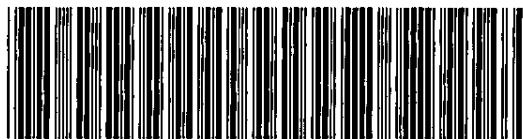

ARTICLE III PURPOSE

This corporation shall be organized for educational and charitable purposes. Such purposes shall include, but shall not be limited to, the study of horticulture, the fine art of gardening, and the artistic use of plant material through educational programs for its members and for the public.
