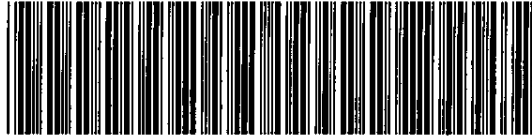

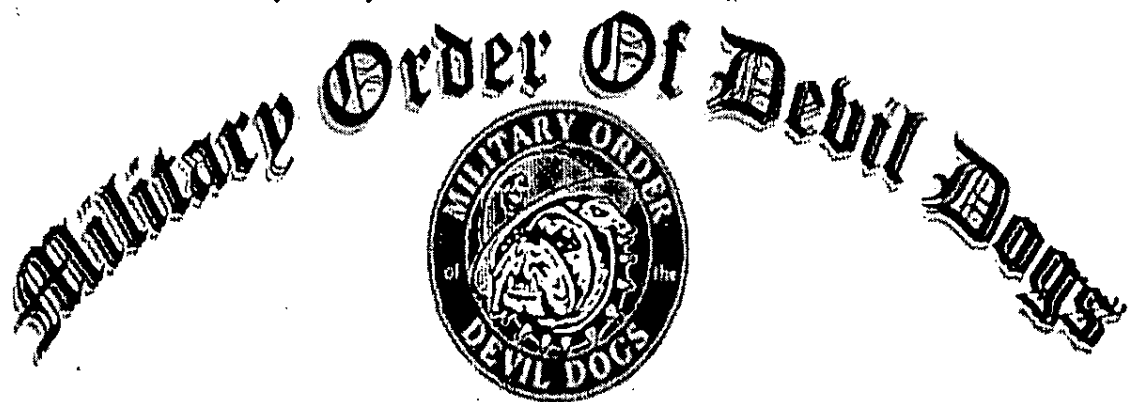

Article I Name of the Corporation
Military Order of the Devil Dogs Pound 263 Inc.

Article II Principal Office
2369 Clinch Dr.

Article III Purpose

1. To promote the social welfare of the community (that is, to promote in some way the common good and general welfare of the people of the community).
2. To assist disabled and needy veterans and members of the U.S. Armed Forces and their dependents and the widows and orphans of deceased veterans.
3. To provide entertainment, care, and assistance to hospitalized veterans or members of the U.S. Armed Forces.
4. To carry on programs to perpetuate the memory of deceased veterans and members of the Armed Forces and to comfort their survivors.
5. To conduct programs for religious, charitable, scientific, literary, or educational purposes.
6. To sponsor or participate in activities of a patriotic nature.
7. To provide social and recreational activities for its members.

Article IV Pound Officers

1. Trustees are Elected Annually in August.
2. The keynote of The Military Order of the Devil Dogs is progress. Upon the Pounds depends the progress of the, Devil Dogs and upon the Pound officers depends the progress of the Pound. It is urged all Pound officers fully realize this, and seriously familiarize themselves with the duties, responsibilities and opportunities of their position. Suggestions for their guidance are incorporated in the Military Order of the Devil Dogs handbook.

Article V Nature

1. This Pound is a civilian organization and membership therein does not affect or increase liability for military or police service.
2. Rank does not exist in The Military Order of the Devil Dogs; no member shall be addressed by his military or naval title in any meeting of this Pound.

Article V Finance

1. The revenue of this Pound shall be derived from membership or initiation fees, from annual membership dues and from such other sources as may be approved by the Pound Executive Committee.
2. The amount of such membership or initiation fees and the amount of such annual Pound dues shall be fixed and determined by this Pound.
3. The Pound shall forward to Pack and Kennel annual membership dues for every member of the Pound, when received from member.

Article VI

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Third hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Article VII DEBT OBLIGATIONS AND PERSONAL LIABILITY

No member, officer or Director of this corporation shall be personally liable for the debts or obligations of this corporation of any nature whatsoever, nor shall any of the property of the members, officers or Directors be subject to the payment of the debts or obligations of this corporation.

Article VIII DISSOLUTION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the , Pack of Florida Military Order of the Devil Dogs or Kennel Military Order of the Devil Dogs. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
