The Articles of Incorporation of the Association are hereby amended to include the following name of the corporation: Jaxson Estates Community Association, Inc.

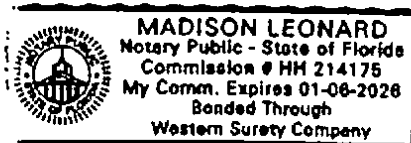
