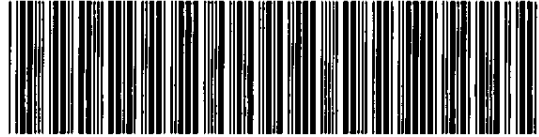

Article 1.

The name of the corporation is Coastal Community Church of Fort Walton Beach, Inc.

Article 2.

The initial registered office of the Corporation shall be at 899 Denton Blvd. NW, Fort Walton Beach, FL 32547. The initial registered agent of the Corporation at such address shall be: James M. Oliver.

Article 3.

Article 4.

The Corporation shall not have Members.

Article 5.

The initial principal office and mailing address of the Corporation shall be at: 899 Denton Blvd. NW, Fort Walton Beach, Florida 32547.

Article 7.

The Corporation is organized exclusively for charitable, educational or religious purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code of 1986, as amended (the "Code") (or the corresponding provision of any future United States Internal Revenue Law), including, but not limited to the following:

1. A church based on the Christian, Non-Denominational faith.
2. To bring together individuals of different races, colors, ages and social-economic backgrounds in a spiritual manner.
3. To fulfill the word of God by keeping the unity of the Spirit in the bond of peace.

Article 8.

The Corporation shall have perpetual duration.

Article 9.

Article 11.

Upon dissolution of the Corporation, the Board of Directors shall, after paying or making provisions for the payment of all of the liabilities of the Corporation exclusively for the purpose of the Corporation in such manner, or to such organizations organized and operated exclusively for charitable, scientific, literary, religious or educational purposes and shall at the time qualify as an exempt organization described in Section 501(c) (3). Ant such assets not disposed of shall be disposed of by the Superior Court of the County in which the principal office of the Corporation is then located, to another organization as said the court shall determine, to be used in such a manner as in the judgment of the court will best accomplish the general purposes for which the dissolved organization was organized.

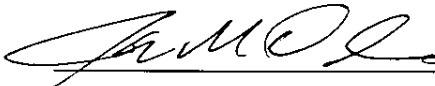
