CERTIFICATE OF AMENDMENT TO ARTICLES OF INCORPORATION OF ST. MARY MAGDALENE COPTIC ORTHODOX CHURCH, INC.

Entity Information

The name of the filing entity is ST. MARY MAGDALENE COPTIC ORTHODOX CHURCH, INC. a Florida nonprofit corporation formed on December 24, 2007, and whose document number issued by the Florida Division of Corporation is N07000012230.

Amendment

The following amendments to the Articles of Incorporation were adopted by a majority vote of the board of directors:

ADD Article VIII and Article IX to read as follows:

ARTICLE VIII

The Coptic Orthodox Church defines marriage as one of the seven Mysteries (Sacraments) of the Church, officiated by a consecrated Coptic Orthodox bishop, priest, or both (or other Orthodox bishop, priest, or both, who is/are in full communion with the Coptic Orthodox Church), in good standing, uniting one man and one woman. The Coptic Orthodox Church defines a man as a human being having the reproductive sexual organs of a male from birth, and the Coptic Orthodox Church defines a woman as a human being having the reproductive sexual organs of a female from birth.

ARTICLE IX

The Coptic Orthodox Church shall take no action(s) contrary to the rules, statutes, regulations and usages of the Coptic Orthodox Church of Alexandria adopted by the Holy Synod of the Coptic Orthodox Church as well as the Synodical Committee for the Coptic Orthodox Churches in the land of immigration.

Statement of Approval

The foregoing amendments to the Articles of Incorporation have been approved in the manner required by the Florida Business Organizations Code and by the governing documents of the Corporation. This document becomes effective when filed by the Florida Secretary of State.
