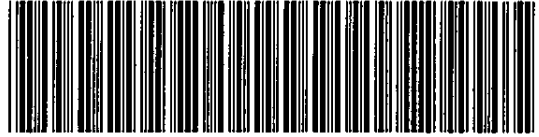

ARTICLES OF INCORPORATION
OF

The undersigned incorporator hereby desires and agrees to form a not-for-profit corporation under the provisions of Chapter 617 Florida Statutes and says:

ARTICLE I

NAME OF CORPORATION, MAILING ADDRESS AND PRINCIPAL OFFICE

The name of this Corporation shall be Multifaith Education Project, Inc. The mailing address of the Corporation shall be P.O. Box 301003, Fern Park, Florida 32730. The principal office of the Corporation shall be located at 612 Woodridge Drive, Fern Park, Florida 32730.

ARTICLE II

REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation shall be 612 Woodridge Drive, Fern Park FL 32730, and the name of the initial registered agent for the Corporation shall be Louise Sheehy.

ARTICLE III

POWERS, OBJECTS AND PURPOSES

The primary purpose for which this Corporation is formed is the education of Jewish, Muslim and Christian students in multifaith relations.

This Corporation shall be authorized to exercise the powers permitted nonprofit corporations under Chapter 617 of the Florida Statutes; provided, however, that this Corporation, in exercising any one or more of such powers, shall do so in furtherance of the exempt purposes for which it has been organized within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986, and provided further that this Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(6) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV

MEMBERSHIP

The qualification for members and the manner of their admission shall be as regulated by the Bylaws.

ARTICLE V

TERM

This Corporation shall have perpetual existence unless sooner dissolved according to the law.

ARTICLE VI

NAME AND ADDRESS OF SUBSCRIBER

ARTICLE VII

BOARD OF DIRECTORS

Section 1. The number of directors constituting the first Board of Directors shall be three (3). Thereafter, the number of directors constituting the Board shall be as provided in the Bylaws of the Corporation; provided, however, that there shall never be less than three (3) directors.

Section 2. The names and addresses of the first Board of Directors who shall serve until their successors are elected or appointed at the first annual meeting of the membership of the Corporation are as follows:

ARTICLE VIII

NON-PROFIT STATUS AND DISSOLUTION

Section 1. No part of the net earnings of the Corporation shall inure to the benefit of any individual or member. When appropriate, the Board of Directors may determine to reasonably compensate any member of the Corporation in accordance with and commensurate with the labor, service or other endeavor performed by such person.

Section 2. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c) of the Internal Revenue Code of 1986, or corresponding sections of any future law, or to the Federal, State, or local government for exclusive public purpose.
