ARTICLES OF INCORPORATION

OF

MULTIFAITH EDUCATION PROJECT, INC.



The undersigned incorporator hereby desires and agrees to form a not-for-profit corporation under the provisions of Chapter 617 Florida Statutes and says:

ARTICLE I

NAME OF CORPORATION, MAILING ADDRESS AND PRINCIPAL OFFICE

The name of this Corporation shall be <u>Multifaith Education Project</u>, <u>Inc.</u> The mailing address of the Corporation shall be <u>P.O. Box 301003</u>, <u>Fern Park</u>, <u>Florida 32730</u>. The principal office of the Corporation shall be located at <u>612 Woodridge Drive</u>, <u>Fern Park</u>, <u>Florida 32730</u>.

ARTICLE II

REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation shall be 612 Woodridge Drive, Fern Park FL 32730, and the name of the initial registered agent for the Corporation shall be Louise Sheehy.

ARTICLE III

POWERS, OBJECTS AND PURPOSES

The primary purpose for which this Corporation is formed is the education of Jewish,

Muslim and Christian students in multifaith relations.

This Corporation shall be authorized to exercise the powers permitted nonprofit corporations under Chapter 617 of the Florida Statues; provided, however, that this Corporation, in exercising any one or more of such powers, shall do so in furtherance of the exempt purposes for which it has been organized within the meaning of Section 501(c)(6) of the Internal Revenue Code of 1986, and provided further that this Corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from Federal income tax under Section 501(c)(6) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV

MEMBERSHIP

The qualification for members and the manner of their admission shall be as regulated by the Bylaws.

ARTICLE V

TERM

This Corporation shall have perpetual existence unless sooner dissolved according to the law.

ARTICLE VI

Section 2. In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c) of the Internal Revenue Code of 1986, or corresponding sections of any future law, or to the Federal, State, or local government for exclusive public purpose.
