

Under the provisions of F.S. 617.1402 the Florida Corporation not-for-profit submits the following articles of dissolution:


**FIRST:** The name of the corporation is KIWANIS PARK FOUNDATION OF PORT CHARLOTTE, INC.

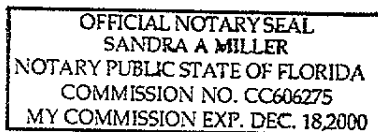


