The Association's Registered Agent and Treasurer, Mr. Russell G. Cameron; 4317 Harbour Island Drive, Jacksonville, FL 32225 became ill in late 2005 and was committed to nursing and care facilities throughout 2006 until his death in the spring of 2007. The turnover to the new treasurer, in 2005, was basically a records pickup because of Mr. Cameron's state of health. No record of notices to renew was received by the new treasurer nor was there any indication of receipt by Mr. Cameron's widow/family. Since this renewal and submission of the annual report had been done exclusively by Mr. Cameron, neither the new treasurer nor the other officers recognized the discrepancy or were not familiar with the requirement.
