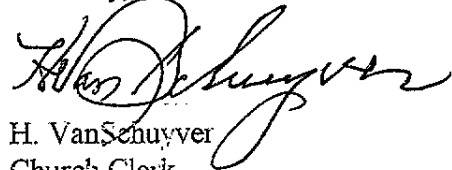
Dear Ms. Harris:

Bradfordville First Baptist Church, Inc.

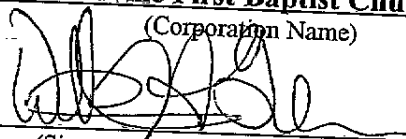
SECOND: The date of the amendment was at the quarterly business meeting, **April 21, 1999.**
