#### ARTICLES OF INCORPORATION OF

#### A FLORIDA CORPORATION NOT-FOR-PROFIT

In Compliance with Chapter 617, F.S., (Not for Profit)

#### ARTICLE I

#### NAME

The name of this corporation was Richmond Heights Homeowners Association, Inc. and shall be forthwith changed for the benefit of all who reside in the community of Richmond Heights to:

RICHMOND HEIGHTS COMMUNITY ASSOCIATION, INC.

#### ARTICLE II

#### PRINCIPAL ADDRESS

This principal place of business of this Corporation is  $11225~\rm SW~152^{nd}$  Street, Miami, Florida 33157. The principal mailing address of this Corporation is  $12073~\rm S.W.~147^{th}$  Street, Miami, Florida 33186.

#### ARTICLE III

#### PURPOSES

The purposes of this Corporation are as follows:


