**ARTICLES OF AMENDMENT  
TO  
THE RESTATED ARTICLES OF INCORPORATION

Pursuant to Section 617.1006, Florida Statutes, the Restated Articles of Incorporation of HELPING ABUSED, NEGLECTED, DISADVANTAGED YOUTH, INC., a Florida not for profit corporation (the "Corporation"), are hereby amended according to these Articles of Amendment:

FIRST: The name of the Corporation is Helping Abused, Neglected, Disadvantaged Youth, Inc.

SECOND: The Restated Articles of Incorporation of the Corporation are hereby amended by deleting the entire Article I as it now exists and inserting in lieu thereof a new Article I, reading as follows:

"Article I


The name of the corporation is:

Helping Advance and Nurture the Development of Youth, Inc."

THIRD: The effective date shall be the date these Articles of Amendment to the Restated Articles of Incorporation are approved by the Florida Secretary of State.

FOURTH: There are no members or members entitled to vote. The foregoing amendment was adopted by written consent of the board of directors on August 16, 2023, and the number of votes cast for the amendment was sufficient for approval.
