The general management of the affairs of the Church shall be vested in the Pastor, Deacons, and Trustees.

No member shall have any right, title or interest in any property or assets, including any earnings or investment income of the Church, nor shall any of such property or assets be distributed to any member on dissolution or winding up the Church.

New Judson Missionary Baptist Church, Inc. shall be personally liable for any of the Church's debts, liabilities, or obligations, no member shall be subject to any assessment.
