#### **ARTICLE I- NAME**

The name of this Corporation is APOSTOLIC REFUGE TABERNACLE, INC...

#### ARTICLE II- PRINCIPAL OFFICE

## ARTICLE III- NATURE OF BUSINESS

The purpose(s) for which this Corporation is organized is (are): To operate a NOT-FOR-PROFIT RELIGIOUS ORGANIZATION, TO EDIFY, TRAIN, DEVELOP MOBILIZE & RELEASE AMBASSADORS OF CHRIST WHO WILL BE ABLE TO EFFECTIVELY COMMUNICATE AND APPLY THE PRINCIPLES OF OUR LORD JESUS CHRIST. - A. - B. Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of 501©(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes.

#### ARTICLE IV- MANNER OF ELECTION OF DIRECTORS

The manner in which the Directors are qualified, elected or appointed is as follows: Each year at its General Annual Meeting, the members of the Corporation shall elect a Board of Director to serve for the ensuing year as provided for in the by-laws.

#### ARTICLE V- REGULATION OF INTERNAL AFFAIRS
