Pursuant to the provision of the Nonprofit Corporation Act of this state, the undersigned incorporators hereby adopt the following Articles of Incorporation:

**Article 1**

The name of this corporation is Glorious Kingdom Ministries, Inc.

**Article 2**

The principal place of business and mailing address of the corporation shall be:

**Article 3**

The purposes for which this corporation is organized are for religious purposes within the meaning of 501(c)3 of the Internal Revenue Code. The specific purpose of the corporation is to promote the Gospel of Jesus Christ to the general public through means such as preaching, teaching, publishing, and other means allowable by Section 501(c)(3) of the Internal Revenue Code.

**Article 4**

The manner in which the directors are elected or appointed are: as stated in the bylaws of this corporation.

Additional provisions:

The property of this corporation is irrevocably dedicated to religious purposes. Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation, or corporation which is organized and operated exclusively for religious purposes and has established its tax-exempt status under Section 501(c)(3) of the Internal Revenue Code.

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributed to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for

services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
