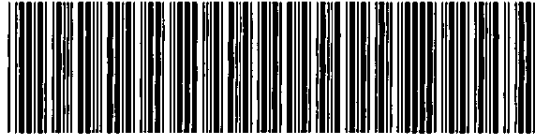

The following are instructions, a cover letter and sample articles of incorporation pursuant to Chapter 617, Florida Statutes (F.S.)

NOTE: THIS IS A BASIC FORM MEETING MINIMAL REQUIREMENTS FOR FILING ARTICLES OF INCORPORATION.

Pursuant to Chapter 617.0202, F.S., the articles of incorporation **must** set forth the following:

The Friendship Club 2, Inc. is a social club which provides personal contact and face-to-face fellowship for individuals seeking freedom from alcohol and drug addiction. Members share a common goal directed toward socializing with recovering addicts and alcoholics. The main activity is recovery-centered group meetings offered three times per day for club members.

As a section 501(c)(7) organization, the club generates revenue from the collection of dues and donations from club members, and the excess is used exclusively for club improvements and benefits for members, such as reduced dues. There are no paid employees, and the members alone provide all financial support.

Article VI: Dissolution of Assets.

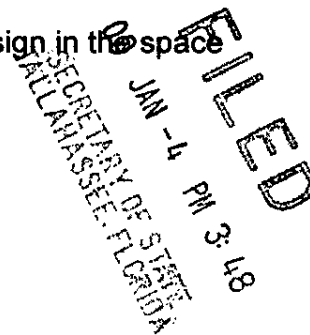
