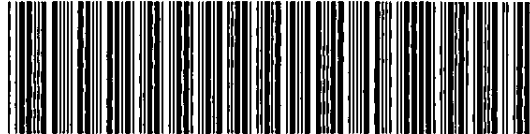

**ARTICLES OF INCORPORATION  
OF**

***KIDS DISCOVERY OUTREACH MINISTRIES, INC.***

**ARTICLE I.**

The name of the Corporation is "*KIDS DISCOVERY OUTREACH MINISTRIES, INC.*"

**ARTICLE II.**

The Corporation is organized pursuant to the Florida Non-Profit Corporation Code.

**ARTICLE III.**

The Corporation shall have perpetual duration.

**ARTICLE IV.**

The Corporation will be organized exclusively for charitable and educational purpose within the meaning of Section 501(c)(3) of the 1986 International Revenue Code.

**ARTICLE V.**

The method of election of the Corporation's directors shall be set forth in the Bylaws of the Corporation.

**ARTICLE VI.**

Notwithstanding any other provision of these articles the corporation will not carry on any other activities not permitted to be carried out by:

a corporation exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any future United States Internal Revenue Law; or

a corporation contributions to which are deductible under Section 178(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Revenue Law.

**ARTICLE VII.**

The initial registered office of the Corporation shall be **4240 Bear Lakes Court # 204, West Palm Beach, Florida 33409** and the initial registered agent of the Corporation at such address shall be **Minister Timothy Blackwell**.

**ARTICLE VIII.**

The initial mailing address of the principal office of the corporation shall be **4240 Bear Lakes Court # 204, West Palm Beach, Florida 33409**.

**ARTICLE IX.**


