ARTICLE II PURPOSE

2. Agape World Christian Ministries and Training Center will include the owning and operating on non-commercial broadcasting stations for educational programming pertaining to preventative health and addictions, family life and relationships, spiritual and mental development programming for children and adults, utilizing Adventist Biblical principles, science, history and music.

ARTICLE VIII DISSOLUTION

Upon the time of dissolution of the corporation, assets shall be distributed by the Board of Directors, to another 501(c)(3) with a similar mission and philosophy, after paying or making provisions for the payment of all debts, obligations, liabilities, costs and expenses of the corporation, for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
