**ARTICLE I**  
**NAME**

The name of the Corporation shall be:

Love And Hope In Action, Inc.

**ARTICLE II**  
**PRINCIPAL OFFICE**

The principal office of the Corporation shall be in unincorporated Martin County, in the State of Florida. The principal place of business and mailing address shall be:

**ARTICLE III**  
**PURPOSE**

Love And Hope In Action, Inc. is organized and created as a nonprofit corporation under the laws of the State of Florida exclusively for charitable purposes, and shall solicit tax exempt 501(c)(3) status from the United States Internal Revenue Service. The purpose of the organization shall be to meet the needs of the homeless as well as the indigent.

In the administration of the above stated purpose, Love And Hope In Action, Inc. shall not discriminate on the basis of race, creed, religion, or gender against anyone in need of assistance.

No part of the earnings of the Corporation shall inure to the benefit of, or be distributable to, its officers, directors, members, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered, and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing and/or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office. Notwithstanding any other provision of these articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of this Corporation.

Upon the dissolution of the Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, as provided in the By-Laws of the Corporation.

**ARTICLE IV  
MANNER OF ELECTION**

The Board of Directors of Love And Hope In Action, Inc. shall be elected in the manner prescribed in the By-Laws of the Corporation.
