ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

LIFE HOPE CHURCH OF ORLANDO, INC.



Pursuant to the requirements of Sections 617.1002 and 617.1006, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment to the Articles of Incorporation of LIFE HOPE CHURCH OF ORLANDO, INC. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on January 9, 2008.

- 1. The Articles of Incorporation (the "Articles") of the Corporation contained a scrivener's error in that the date set forth on the first page of the Articles ("Adopted January 6, 2007") sets forth the wrong year. The correct date that the Articles were adopted is January 6, 2008.
- 2. The same error also affects the last page and signature line of the Articles, which states that the Articles were "DATED January 6, 2007." Again, the correct date of the Articles is January 6, 2008.

- 4. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.
- 5. The foregoing amendment to the Articles of Incorporation was unanimously adopted by all the members of the Board of Directors on the 25th day of May, 2008. Member approval is not required for any amendments to the Corporation's Articles of Incorporation, as the Board of Directors has sole authority to amend the Articles of Incorporation.
