Hereinafter set forth are the Articles of Incorporation pursuant to Florida Corporations  
Law Statute 617.hall be as

ARTICLE I  
NAME OF CORPORATION

The name of the corporation shall be as follows:

JAX NON-VIOLENT COMMUNITY DEVELOPMENT CORP.  
( A NON-PROFIT CORPORATION )

ARTICLE II  
PURPOSES

1. To stop violence among youth.
2. To develop and distribute non-violent C D's to aid in the alleviation of social and economic ills that plague the youth of our society.
3. To develop affordable housing for the economically disadvantaged and displaced.
4. To be organized and operated exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations under section 501 ( c ) ( 3 ) of the internal revenue code, or any corresponding section of any future internal revenue code.
5. To engage in any other legal activities necessary to the achievement of corporate goals

#### ARTICLE IV DISSOLUTION

Upon dissolution or winding up of the corporation, assets remaining after payment, or provision for payment, of debts and liabilities of this corporation shall be distributed to a charitable a non-profit fund, foundation or corporation which is organized and operated exclusively for charitable purposes and which has established its exempt status under section 501 ( c ) ( 3 ) of the Internal revenue Code or any future Internal Revenue code.

Any such assets disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located, exclusively for such purposes or to such organization (s), as the court shall determine, which is organized and operated for such purposes.

#### ARTICLE V LIMITATION OF POWERS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or any private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of its purposes set forth in Article II thereof.

No substantial part of the activities of the corporations shall be carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in ( including the publishing or distribution of statements ) or any political campaign on behalf of the opposition to any candidate for public office.




#### ARTICLE VI BOARD OF DIRECTORS

Bylaws of the corporation will be formulated and implemented by the initial Board of Directors once appointed.


