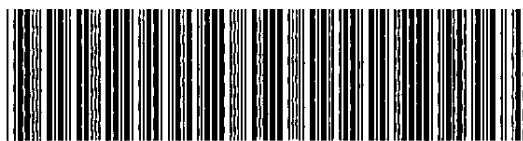

One: The name address of this principal corporation is: Carnegie Community Center, Inc. 6905 SW 57th Road Gainesville, Fl 32608. The corporation is organized pursuant to the Florida Nonprofit Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes, religious, and educational purposes. the making of distributions to organizations that qualify as exempt organizations under section 501 (C) 3 of the internal Revenue Code. The programs will consist of, but shall not be limited to: Child Care, Job Training, Job Placement, Land Acquisition, Housing, Employment, Literacy, Counseling, Temporary Shelter, Teenage Pregnancy, Substance Abuse Awareness and Prevention, Tutoring, AIDS, Elderly Care and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.

I am familiar with and accept the appointment as registered agent and agree to act in this capacity.

- a) This corporation is organized and operated exclusively for Religious, Charitable, Scientific and Education purposes within the meaning of Section 501(c) (3) of the Internal Revenue Code.
- (b) Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to carry on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a Corresponding section of any future federal tax code..

(C) No substantial part of the corporation Shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing of distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.
