As per your request, below are more details about the activities of our organization. Our first project as an organization has been named Rhythms of Culture – Children Helping Children. As we embark in this project the first hosting country is Honduras in 2008, followed by the United States in mid 2009, and Colombia and Guatemala in the second part of the year. Upon completion of the various tours and our goals for this project other countries will follow. As new countries are added, we will work with local foundations that serve underprivileged children in these countries and extend an invitation to share their culture and folklore not only with the audience but also with the participating children.

The first cultural exchange will take place between September 30th and October 4th of this year in Honduras. These are the participants of the upcoming tour: 30 Afro-Colombian displaced and vulnerable children living in extreme poverty from the Batuta Foundation Center in "Barrio el Pozón", in Cartagena, Colombia. 18 Children of Maya descent from the Mayan Dance Group Wajshaquib Batz in Quetzaltenango, Guatemala and 18 Honduran and Garifuna high risk children from the Honduran Institute for Children and Families (IHNFA) from La Pradera Center. These groups will join Yasmine and Anthony of Yasmanth, in Rhythms of Culture, Children Helping Children in Honduras.

Type of Dance Performances

The dance and music performances will include: Dances from the Silk Road originating from the Autonomous Region of Uygur in Xinjiang, China, Tajikistan and Uzbekistan. We will have dances from Asia and the Middle East. We will host performances with the "dumbek" (Arab drum) as well as, Egyptian and Turkish rhythms performance. In addition, we shall have performances of Afro-Colombian, Colombian, Honduran, Garifuna and Maya cultures. The dances and musical performances will be presented in traditional, original costumes and music with unique traditional instruments.

Cultural Exchange

The Cultural Exchange has several facets and stages. Before arriving in the hosting countries all the participants will take part in local classes provided by a teacher, which will engage them in the history, traditions and customs of the country they will visit. In essence, this provides an early opportunity to obtain all the information possible about each of the countries involved to prepare the participants for their arrival and first encounter. Once in Honduras, (the first host), we will experience a full cultural immersion, sharing living quarters with the local children performing, eating Honduran traditional foods, sharing Garifuna dances and music, visiting museums, historical places and experiencing lectures by locals in interactive sessions. The culmination of the exchange is the four performances in Tegucigalpa Honduras; three of those performances will be for underprivileged children of local schools, and one for the general public.

U.S. Performances in Other Countries and vice-versa

Yes, US performances will be an integral part of the cultural exchanges in each of the countries where events are organized and in June of 2009 we will be bringing Rhythms of Culture, Children Helping Children to the United States. We are planning to

provide performances for local underprivileged children and the general public in various US cities. As part of the US tour an invitation to the local Native American community in Florida is being planned to invite them to share their culture and participate in the cultural exchange.

Workshops and Learning Program

Since culture is composed of many aspects we are creating various types of learning programs. First and most important is teaching tolerance, respect and understanding for the many cultures of the world. We will accomplish this by focusing the workshops on activities that highlight what we have in common with each other, and what makes us special; not so much our differences. Utilizing a template covering the various aspects that make up a culture, each country participating will prepare a workshop to share with the rest of the groups. The workshops will use various media, such as PowerPoint presentations, video, live demonstrations, question and answer, audience participation and group activities which will enhance the learning experience by making it interactive. To be able to capture the essence of the exchange, all the experiences and workshops that the groups live through during their time together will be documented with video and will include the cultural exchange, interviews with historians and their unique experiences and will be accompanied by the written workshop materials. Copies will be provided to main libraries and cultural entities as a way to educate those who could not participate and to help the efforts of keeping the culture alive. In addition, we will make them available on our website to reach even more people through the internet.

Yasmanth's mission

In addition to helping preserve the cultures of the world we have a unique opportunity to effect a tangible change in the lives of many underprivileged children. Our mission is to provide opportunities for the children participating, for whom this trip represents the first time they leave their towns or villages; many have never seen the ocean, metropolitan cities, airplanes, etc. In addition to the opportunities for these children, we desire that they become the inspiration for other children like themselves, which many times no longer believe in dreams, because their reality, including mistreatment and social indifference has taught them that they do not deserve to have dreams and that opportunities are meant for others. Everyone deserves to be able to dream and to enjoy childhood, to share their culture with pride and be understood.

Yasmanth will establish with the culmination of this tour the unification of cultures, countries, children, social classes and dreams and the preservation of folklore.

During each tour Yasmine will learn dances on the verge of being forgotten and Anthony will learn local percussion and music so as to share it with children in the US. This will be done by providing workshops for children at local schools, libraries, CCD Sunday school and local cultural programs where they can teach them about their experiences and pass on to them the dances, music, culture, anecdotes and segments of what was documented that they can relate with.
