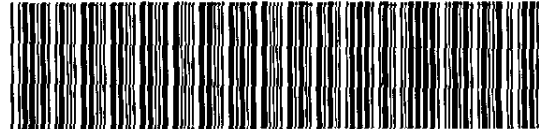



OF

ARTICLE I NAME

Section 1.1 The name of this not for profit corporation shall be:

ARTICLE III EFFECTIVE DATE

Section 3.1 The effective date of these Articles of Incorporation shall be the date these articles are filed with the Secretary of State.

ARTICLE IV PURPOSE

Section 4.1 The specific purpose for which the corporation is organized is to support all athletic related programs at Jay High School and in the Jay Community and for any other lawful purpose under the Florida Not for Profit Corporation Act, and to distribute the income therefrom exclusively for charitable, scientific, literary, or educational purposes, directly or by contribution.

Section 4.2 The corporation shall issue no stock. No part of its earnings shall be distributed to its members, directors, or other private persons, except that this corporation shall be authorized to pay reasonable compensation for services rendered and to make payments and distributions in accordance with the purpose set forth in Section 4.1 of these articles.
