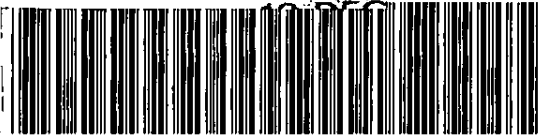

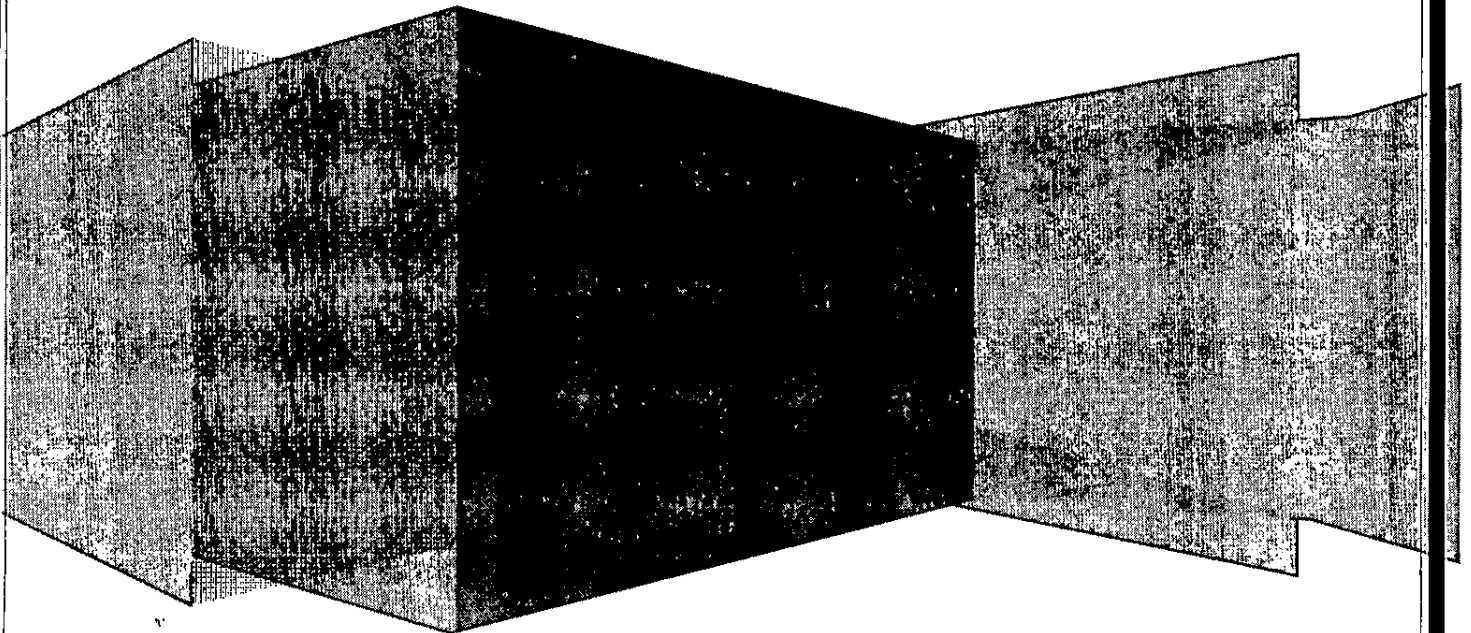
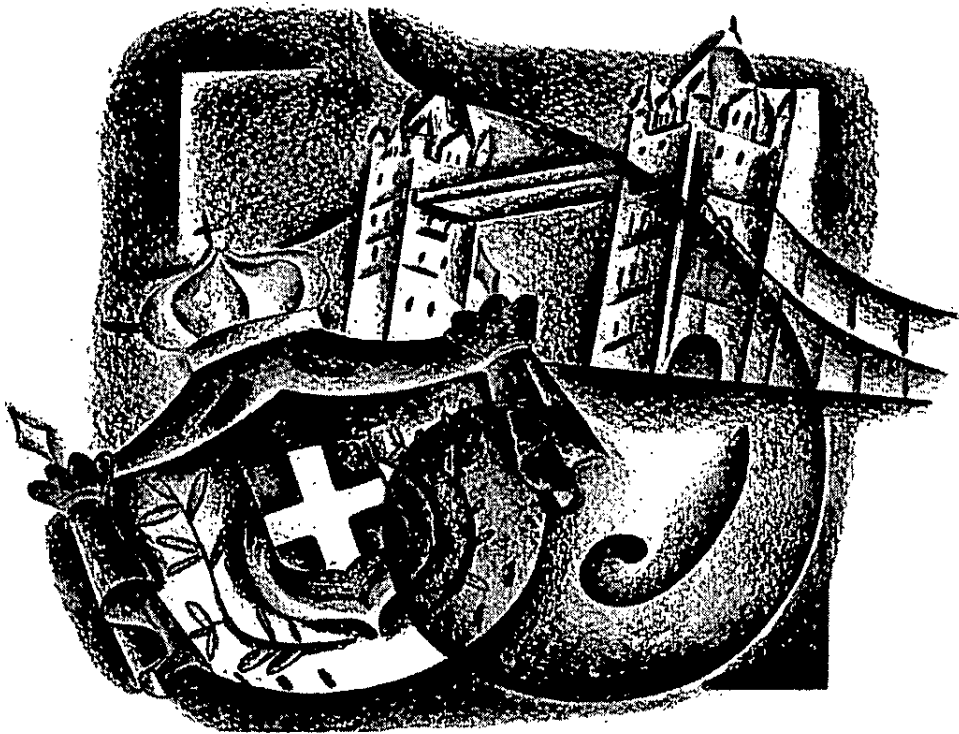

# Articles of Incorporation for a Non Profit Organization

## ARTICLES OF INCORPORATION OF

### ***Project Involvement: Bridging - the - Gap INC.***

The undersigned, acting as incorporators of a corporation under the Non-profit Corporation Act of the State of Florida, adopt the following articles of incorporation for such corporation:

#### ARTICLE I

The name of Incorporation is hereinafter referred to as ***Project Involvement: Bridging - the - Gap INC.***

#### ARTICLE II

The period of duration of ***Project Involvement: Bridging - the - Gap INC.*** is perpetual.

#### ARTICLE III

***Project Involvement: Bridging - the - Gap INC.*** is organized exclusively for community building such as drug prevention, educational resources, and religious purposes, including community building, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. ***Project Involvement: Bridging - the - Gap INC.*** may receive and administer funds for community outreach, drug prevention, educational, and charitable purposes, within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 and to that end, ***Project Involvement: Bridging - the - Gap INC.*** is empowered to hold any property, or any undivided interest therein, without limitation as to amount or value; to dispose of any such property and to invest, reinvest, or deal with the principal or the income in such manner as, in the judgment of the directors, will best promote the purposes of ***Project Involvement: Bridging - the - Gap INC.***, without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the By-Laws of ***Project Involvement: Bridging - the - Gap INC.***, or any applicable laws, to do any other act or thing incidental to or connected with the foregoing purposes or in advancement thereof, but not for the pecuniary profit or financial gain of its directors or officers except as permitted under the Not-for-Profit Corporation Law.

No part of the net earnings of ***Project Involvement: Bridging - the - Gap INC.*** shall inure to the benefit of any member, trustee, officer of ***Project Involvement: Bridging - the - Gap INC.***, or any private individual, except that reasonable compensation may be paid for services rendered to or for ***Project Involvement: Bridging - the - Gap INC.*** affecting one or more of its purposes, and no member, trustee, officer of ***Project Involvement: Bridging - the - Gap INC.***, or any private

individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of ***Project Involvement: Bridging - the - Gap INC.***. No substantial part of the activities of ***Project Involvement: Bridging - the - Gap INC.*** shall be the carrying on of propaganda, or otherwise attempting, to influence legislation, and ***Project Involvement: Bridging - the - Gap INC.*** shall not participate in or intervene in, including the publication or distribution of statements, any political campaign on behalf of any candidate for public office.

Upon the dissolution of ***Project Involvement: Bridging - the - Gap INC.*** or the winding up of its affairs, the assets of ***Project Involvement: Bridging - the - Gap INC.*** shall be distributed exclusively to one or more charitable, religious, community, literary, or educational organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, or to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of ***Project Involvement: Bridging - the - Gap INC.*** is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.

#### ARTICLE IV

The qualifications for members and the manner of their admissions shall be regulated by the by-laws.

#### ARTICLE V

The initial and principal street address in the state of Florida of the initial office of ***Project Involvement: Bridging - the - Gap INC.*** at ***302 NW 5<sup>th</sup> Avenue, Gainesville, Fl 32601.*** The street address of the registering agent, ***Jacqueline Duncan*** is ***2330 SW Williston Road #317 Gainesville, Fl 32608.***

#### ARTICLE VI

The territory in which the operations of ***Project Involvement: Bridging - the - Gap INC.*** are principally to be conducted is the United States of America and its territories and possessions, but the operations of ***Project Involvement: Bridging - the - Gap INC.*** shall not be limited to such territory.
