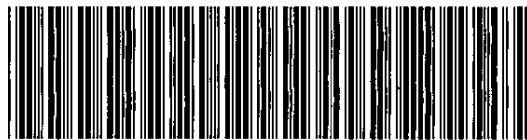

- j) To promote revivals to win souls for Christ through the teaching of the Gospel of Jesus Christ. To establish churches internationally overseas and abroad.
- k) To initiate a youth center, day care, adult and elderly center and to become involve in community affairs in order to build up the community.
- l) To have the power to solicit and raise funds by any and all proper and appropriate means under and subject to the Religious Corporation law, and to receive disburse such funds of money accruing from tithes, offerings, collections or any other Corporation.
- m) To have power to take and hold any grant donation, gift, bequest or devise of real or personal property.
- n) The assets of the Corporation shall be at all times dedicated to the purposes set out above, and none of the net earnings shall inure in whole or in part to the benefit of any private individual, association or corporation. If for any reason it becomes necessary to dissolve or liquidate the Corporation, the remaining assets of the Corporation, after its lawful obligations and all other requirements of law are met and complied with, shall be transferred or conveyed to one or more corporations, societies, or organizations engaged in activities similar to those of the Corporation and qualifying under Section 501 © (3) of the Internal Revenue Code of 1954, as may be specified in a plan of distribution adopted as provided by law or as directed by a court of competent jurisdiction.
