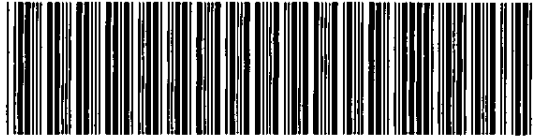

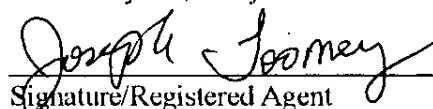

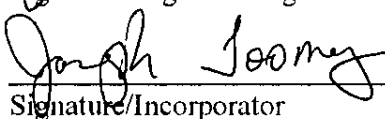

ARTICLE III- PURPOSE
