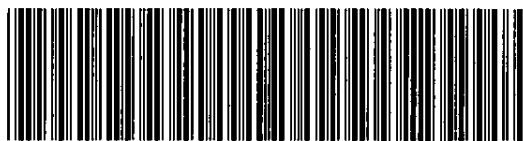

Articles of Incorporation  
The Ruth and Louis Gerstle Foundation, Inc.

Article III    Purpose

The purposes for which the corporation is organized are:

To take hold by bequest, devise, gift, purchase, lease or otherwise, any property, real or personal, without limitation as to value, insofar as the same may be held by a corporation organized under the laws of Florida which govern not-for-profit corporations;

To hold, maintain, use, convey, sell or dispose of such property and to invest, reinvest, administer, collect and receive the income and profits thereof, and expend the principal thereof and income therefrom in any manner as may be permitted by law and as, in the judgment of the Board of Directors, will best promote the purposes for which the corporation is organized;

To apply from time to time the principal thereof and the income therefrom exclusively for charitable, religious, scientific, literary, cultural or educational purposes by such agencies and means as shall, from time to time, be found appropriate therefor, including by contributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code of 1986 and the regulations thereunder as they now exist or as they may hereafter be amended;

To have in furtherance of these purposes, all of the powers conferred upon or permitted to corporations organized under the laws of Florida which govern not-for-profit corporations;

To do any and all lawful acts and things which may be necessary, useful, suitable or proper for the furtherance, accomplishment or attainment of any or all of the purposes of the corporation;

The corporation will distribute the net investment income to organizations qualified under Section 501(c)(3) of the Internal Revenue Code which also qualifies for either public charity status under Section 509(a)-1, 2, or 3 or as a private operating foundation;

Notwithstanding the foregoing, nothing herein contained shall permit this corporation to solicit gifts or contributions from the public.
