#### **ARTICLE III**

Seeking to make a difference, we strive to be responsive to the needs and aspirations of citizens in Central Florida. Through community development, Lily Community Resources, Inc. seeks to advocate for the community and assist the public to develop and implement a dynamic and practical vision of Central Florida residents. We promote personal development and provide opportunities for Central Florida communities to improve their knowledge, skills, health and ultimately their quality of life. In general, we are trying to develop self-sufficiency for participating families. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

The Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes, the making of distributions to organizations that qualify as an exempt organization under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### **ARTICLE VIII**

The property of this corporation is irrevocably dedicated to charitable purposes and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

No substantial part of the activities of the corporation shall consist of the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
