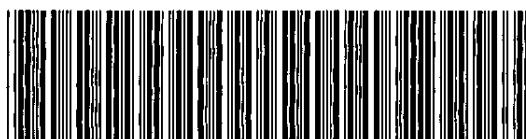
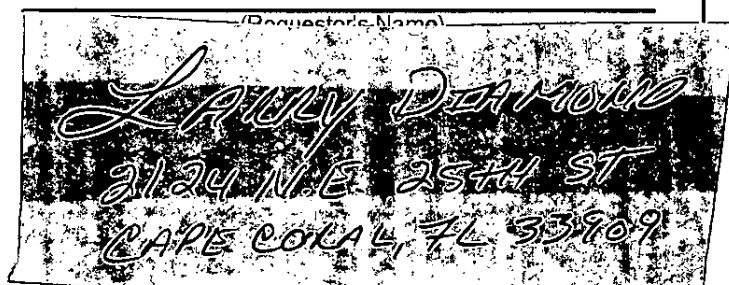

The undersigned incorporation hereby forms a corporation under the laws of the State of Florida as follows:

ARTICLE I.

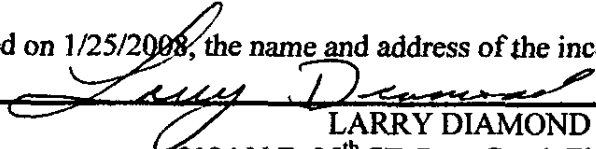
