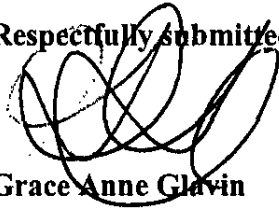

The undersigned, acting as incorporators for this business corporation pursuant to Chapter 617 of the Florida Statutes, hereby form a not-for-profit corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be LAKE HOWELL LITTLE SCHOLARS, INC.

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 8 day of February, 2008, and shall exist perpetually.

ARTICLE III
GENERAL PURPOSE

The general purpose for which this corporation is organized shall be athletic activities for youths and related sales and service and all things in connection therewith that are related under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.

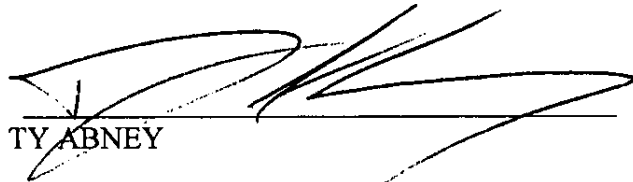
ARTICLE VI

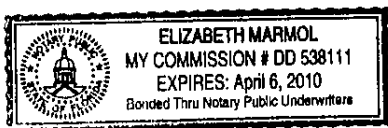

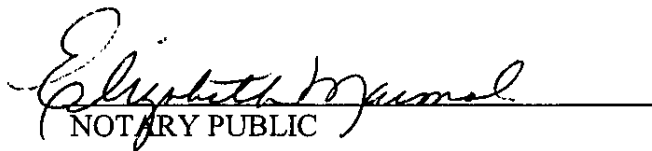

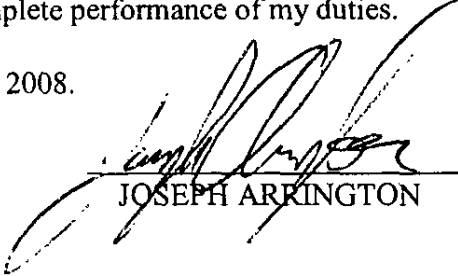
