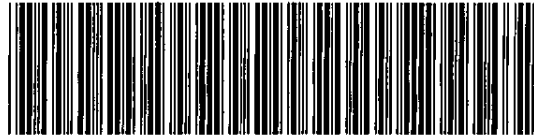

Article I.
Corporate Name

Pursuant to the Laws of the State of Florida, Florida Statute § §617, (2008) the undersigned adopts the following article of incorporation. The name of this non-profit corporation is the **MACEDONIA MISSIONARY BAPTIST CHURCH, A DOMESTIC NON-PROFIT CORPORATION.**

Article II.
Principal Address

Article III.
Nature of Business and Powers

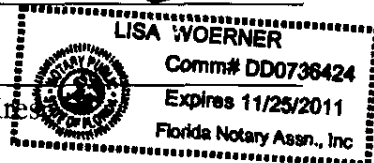
