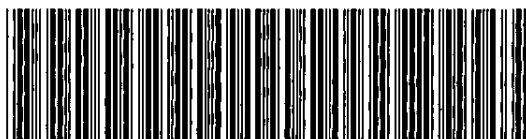

ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I

Name of Incorporation

The name of this Church is: Sure Foundation Christian Ministries, Inc.

ARTICLE II

Principal Office

Section 1.1. The Principal Office. The principal office for the transaction of the business of the Incorporation is hereby fixed and located at:

Section 1.2. The Pastor and the Board of Directors. The Pastors and the Board of Directors can hereby grant full power and authority to change said principal office from one location to another.

ARTICLE III

Purpose

The Purpose for which the incorporation is organized is to reach out and minister to all who need to know the love of Jesus Christ; through public and private worship of God. Through preaching the gospel, consistent to Christian living, missionary endeavors, Christian education, and reaching out beyond the four walls of the edifice or where ever there is a need. The ministry's vision is to help the lost find Jesus Christ and to offer a ministry that welcomes everyone regardless of there past life experiences or station in life. Our focus is to minister to those that are lost so that they can know the love of Jesus Christ.

ARTICLE IV**Manner of Election**

Subject to the foregoing limitation, the Members at any meeting shall determine the number, which shall constitute the Board, and the number so determined shall remain fixed until changed at a subsequent meeting. The Members may designate classes of Directors whose terms shall expire at the next annual meeting ensuing or one or two years thereafter, and may designate which Directors shall be elected to each respective class. The directors shall be elected at each annual meeting of the Members; however, if any such annual meeting is not held or the directors are not elected thereat, the directors may be elected at any meeting of Members held for that purpose. All directors shall hold office until their respective successors are elected.
