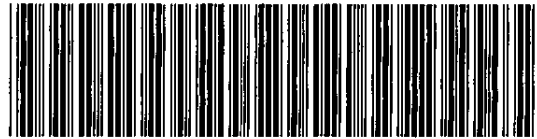

## ARTICLES OF INCORPORATION

### Article I

The name of this corporation shall be, "Church of Holy Faith and Prayer, Inc." It shall be incorporated as a not for profit religious organization under the laws of the State of Florida.

### Article II

The principal place of business and mailing address of this corporation shall be: 220 Gandy Street, in the city of Auburndale, FL 33823. The registered agent in charge thereof is James Thompson of 2727 Ave. M. N.W., Winter Haven, FL 33881.

### Article III

The purpose for which the corporation is organized is:

1. To encourage and promote the evangelization of the gospel of Jesus Christ throughout the world.
2. To encourage and promote the worship of God
3. To encourage and promote the edification of believers.
4. To provide a basis of fellowship among Christians of like faith.
5. To supervise all the activities of "Church of Holy Faith and Prayer."
6. To establish churches and encourage their development.
7. To examine candidates for the ministry and to ordain as ministers those who shall meet the requirements of this fellowship.
8. To approve all scriptural teachings and conduct, and to disapprove all unscriptural teachings and conduct.
